Support to the Development of Higher Education Project (IND 168).**


Reference is made to your letter no. 465/B/IDB/PMU/2017 dated 22/05/2017 submitting the draft contracts for civil works packages and the response on the related financing for the six universities under the subject project.

After review, the Bank has no objection to the draft contracts for the civil works of the six universities. You may proceed to sign the six contracts to be financed by IDB for a revised cumulative price not exceeding 1,766,758,140,196.50 (approximately equivalent to USD 131,847,622.5 at the rate of 1 USD = IDR 13,400), while the Government shall bear the financing for the remaining balance of IDR 117,234,477,007.80 (as committed and conveyed by the Director General of Student and Learning affairs of the project Executing Agency).

We also strongly recommend that the procurement of the furniture and fixtures, under the government financing, for installation in the new buildings constructed under IDB financing, be synchronized and coordinated with the civil works work schedules, so that they can be ready and available for installation once the construction is complete.

Against the foregoing, you may kindly proceed with the signing of the contracts and send copies of the signed contracts to the Bank for its records, along with the advance payment disbursement requests at the earliest opportunity.

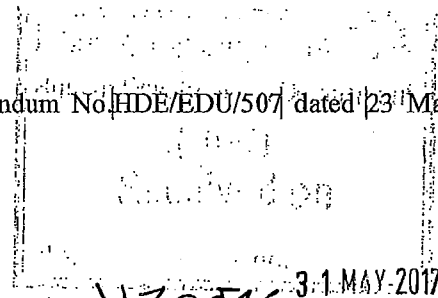
