IDB has reviewed the Prequalification Evaluation Report of six Universities and we are pleased to inform you that overall, IDB has no objection to result of the Prequalification Evaluation Report with special note for the following:

- 1) IDB finds that JV of PT Acsset Indonusa Tbk and PT. Amarta Karya (Persero) should be included in the prequalification list for all of the packages since the understanding is that for JVs, the similar experience should be aggregated in 4.2. (a) in conjunction with the explanation of the footnote.
- 2) Kindly note that IDB concurred with the decision of the Executing Agency to disqualify PT. Brantas Abipraya and its JV for the relevant package.


